RE: Interfaith community supports the Sentencing Reform and Corrections Act, S. 2123

Dear Chairman Grassley and Ranking Member Leahy:

During his speech to a joint meeting of Congress in September, Pope Francis stated that, "a good political leader is one who, with the interests of all in mind, seizes the moment in a spirit of openness and pragmatism. A good political leader always opts to initiate processes rather than possessing spaces."

The undersigned faith organizations agree and we write to thank you, and your colleagues, for your good leadership and hard work to reach consensus on legislation that would reduce harsh sentences and end the unjust incarceration of many thousands of men and women in federal prisons. Today's hearing before the Judiciary Committee regarding the Sentencing Reform and Corrections Act (S. 2123) is a critical turning point for the Committee and the Senate.

Mandatory minimum sentences have contributed to an overwhelming increase in the federal prison population since 1980. These harsh penalties are often unwarranted, particularly for low-level drug offenses, exacerbate racial disparities and perpetuate dangerous prison overcrowding. We believe S. 2123 is an important step toward fixing the federal prison crisis and we thank you for nurturing the political cooperation needed to address this often intractable problem.

Our beliefs direct us to protect the dignity and well-being of everyone impacted by the criminal justice system. That commitment extends to people who are victimized by crime, as well as to those who commit offenses. Again we take inspiration from Pope Francis' words last month, "that a just and necessary punishment must never exclude the dimension of hope and the goal of rehabilitation."

S. 2123's provisions to limit federal life sentences for youth and adults are particularly commendable, and consistent with a respect for human dignity, as are its provisions to end solitary confinement for youth. We are also eager to see this legislation provide for furthering rehabilitative programming, including expanding access to treatment programs and education for those in prison.

While we object to the implementation of new mandatory minimum sentences as currently prescribed in S. 2123, we acknowledge the bill's overall contribution to furthering a fair and proportional justice system. Our organizations look forward to working with you in the coming weeks and months to pass the Sentencing Reform and Corrections Act.
